## Minor Release and Waiver of Liability and Indemnity Agreement (Read Carefully Before Signing)

IN CONSIDERATION of allowing the below MINOR participant to compete and/or participate in any way with Martino MX School and Zach Martino, EACH OF THE UNDERSIGNED, for himself/herself, his/her personal representatives, heirs, and next of kin agrees that:

- 1. The MINOR AND PARENT OR GUARDIAN agree to have read, reviewed, and understand the Martino MX School Registration Form.
- 2. THE MINOR AND PARENT OR GUARDIAN HEREBY ASSUME FULL RESPONSIBILITY FOR ALL RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to negligence of Releases (as identified below) or otherwise, while attending and/or participating in any way for any purpose at said event. The undersigned recognize and understand that there are risks and dangers associated with participation in Martino MX School are assumed notwithstanding.
- 3. THE MINOR AND PARENT OR GUARDIAN release, waive, discharge and covenant not to sue Martino MX School, Zach Martino, and/or any affiliates associated with Martino MX School, staff, sponsors, suppliers, manufacturers, advertisers, equipment and parts manufacturers, and/or any affiliated entities thereof, all for the purposes herein referred to a "RELEASES", from all liability to ourselves, the undersigned's, our personal guardian on account of any injury, including but not limited to the death or injury of the parent/guardian or MINOR or damage to property, all of which is caused or alleged to be caused by the negligence of the RELEASEES or otherwise.

This RELEASE and WAIVER of LIABILITY, ASSUMPTION of RISK and INDEMNITY AGREEMENT extends to all acts of negligence by the RELEASEES, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the State of Illinois and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THIS AGRREEMENT SHALL BE INTERPRETED UNDER THE LAWS OF THE STATE OF ILLINOIS. IF ANY PART OF THIS AGREEMENT IS ADJUDGED TO BE INVALID FOR ANY REASON, I AGREE THAT THE REMAINING TERMS OF THE AGREEMENT REMAIN IN FULL FORCE AND EFFECT.

THE PARENT OR GUARDIAN HAS READ AND VOLUNTARILY SIGNS THE WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT AND DOES SO VOLUNTARILY AND WITH THE UNDERSTANDING THAT SUBSTANTIAL RIGHTS ARE BEING GIVEN UP.
